The Colorado Asylum Center (CAC) provides assistance to asylum applicants who cannot afford legal representation.

- Services include I-589 (asylum application) clinics, legal consultations, appeals clinics, work permit clinics, and limited individual representation before the immigration court, the Board of Immigration Appeals, and the Tenth Circuit Court of Appeals.
- The CAC will also begin providing assistance to unaccompanied children in 2026 for SIJ predicate orders and I-360 filings.

Colorado Legal Services (CLS) is a statewide legal aid providing free legal advice, clinics, and representation to low-income Coloradans and seniors. CLS has 13 offices across the state, as well as several statewide units located in Denver. CLS services are available to certain noncitizens, including any noncitizen who has been the victim of a crime, regardless of status.

- The **Survivor Services Unit (SSU)** is a statewide unit representing Coloradans who have been victims of certain kinds of crime and/or serious labor violations. The SSU specializes in representation of noncitizens for T visas, U visas, and VAWA self-petitions, among other forms of relief.

Limited to agricultural workers who are victims of work-related crimes, including human trafficking, as well as agricultural workers seeking to become naturalized U.S. citizens.
